Through the years the farm has grown pumpkins for its month long Harvest Festival. Around 1990 a small tree and shrub nursery was started by Tom Manza which quickly expanded to meet the growing needs of the area. Today it encompasses 20 acres of above ground for future needs. The garden center has a very large selection of trees, shrubs, perennials and grasses and is know for its high quality and value pricing.
